This Agreement is made by and between _____
(name of Film Maker, studio, or company presenting film) (the "Film Maker")
and Christian Youth Film Society, Inc. ("CYFS")

1. Subject of Agreement

Film Maker provides to CYFS the film entitled _____
(the "Film") to use according to the terms set out under this agreement.

2. Licensed Rights

Film Maker hereby grants to CYFS the irrevocable Licensed Rights to the Film subject to all the terms and conditions hereinafter set forth. The Licensed Rights are Non-Exclusive, Worldwide, and in Perpetuity. Rights include all types and variations of: Broadcast, Video On Demand, and Theater. All rights include the right to copy, store, archive, and distribute the Film. CYFS is entitled to assign/sublicense all Licensed Rights to third parties and/or to affiliates and contracting partners for distribution in whole or in parts.

3. Unrestricted Adaptation and Alteration

CYFS is entitled to make intermissions, alterations, deletions, cuts, or other modifications in and to the Film only to adapt the Film to suit available time slots, to enable advertising breaks and online inventory, for the protection of minors, or to create trailers. This also includes the right to alter the title of the Film. Other than for said reasons the Film shall be distributed unaltered.

4. Language / Dubbing and Subtitling

CYFS is entitled to dub and/or subtitle and/or voice-over the Film in any language (even the original). CYFS has the right to exploit the Film in the dubbed, subtitled, or voiced-over version. CYFS shall grant free access to Film Maker to any dubbed or subtitled version of the Film created by CYFS.

5. Credits:

CYFS undertakes that all Credits provided by Film Maker will be given in accordance with the usual practice in the film and television industry. Therefore CYFS may alter the Credits to a market standard and reduce the end-credits and/or copyright notices so that they can be displayed on a split-screen or condensed using visual effects or time compress the said end-credits and/or copyright notices, provided that the same remain reasonably legible.

6. Representations and Warranties, Indemnification

Film Maker represents and warrants that:

- i. it has the full right and authority to enter into this Agreement.
- ii. it is the sole owner of all rights under this Agreement including copyrights and any such rights originally vesting in third parties and that it is authorized to dispose over such rights to the benefit of the CYFS.
- iii. any music within the Program does not infringe or violate the trademark, trade name, copyright, right of privacy or publicity, property rights or any other right of any third party.
- iv. the Film does not contain material that is unlawful or promote illegal or unlawful activities, including illegal product placement.

Film Maker shall indemnify and hold CYFS harmless against all actions, claims, costs (including reasonable legal costs and settlements and other payments), proceedings, direct and indirect damages, expenses, or fines arising out of any breach or non-performance by Film Maker, in particular of any warranty given by it or obligation undertaken by it in this Agreement, save for all required licenses for the performance rights in relation to the distribution of the Film by CYFS.

7. Overspill

CYFS shall have no obligation or liability hereunder in case of unintentional, non-encrypted broadcasts resulting from technical defaults and/or technical spillover beyond the licensed Territory including non geo-blocked Internet Protocol or un-encrypted satellite overspill from an uplink in the licensed territory.

8. Termination

Either party is entitled to terminate this Agreement extraordinarily at any time if the other party is in material default of this Agreement and fails to cure such default within thirty (30) working days of receiving written notice thereof.
